## <u>Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements)</u> <u>Regulations, 2015 (Listing Regulations) - Appointment of Statutory Auditors</u>

The Reserve Bank of India ("RBI") vide Circular No. RBI/2021-22/25/Ref.No.DoS. CO.ARG/SEC.01/08.91.001 / 2021-22 dated April 27, 2021, issued Guidelines for Appointment of Statutory Central Auditors (SCAs)/Statutory Auditors (SAs) of Commercial Banks (excluding RRBs), UCBs and NBFCs (including HFCs) (the "RBI Guidelines"). Further, as per the said RBI Guidelines, the appointment of SCAs/SAs shall be implemented for the first time for UCBs and NBFCs from Financial Year 2021-22 and such entities have the flexibility to adopt these guidelines from the second half of Financial Year 2021-22.

In view of the aforesaid RBI Guidelines, we wish to inform you that the Board of Directors at their meeting dated October 29, 2021 have recommended to the Members of the Company, the appointment of M/s. T.R. Chadha & Co. LLP, Chartered Accountants, (Firm Registration No. 006711N/N500028) as the Statutory Auditors of the Company for a period of 3 (three) consecutive years to hold office with effect from the date on which the Members of the Company would approve the said appointment and until the conclusion of the 15th Annual General Meeting to be held in the calendar year 2024, subject to the said firm continuing to fulfill their applicable eligibility norms.

The Company would be seeking the approval of the Members for the appointment of M/s. T.R. Chadha & Co. LLP, Chartered Accountants as aforesaid, by way of Postal Ballot in accordance with Section 110 of the Companies Act, 2013 read with Rules made thereunder and relevant circulars issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India. The Postal Ballot Notice will be submitted to the Stock Exchanges simultaneously with sending of the same to the Members of the Company.

Information of appointing Auditors in terms of SEBI Circular no. CIR/CFD/CMD/4/ 2015 dated September 09,2015 is enclosed as 'Annexure A'.

You are requested to take note of the above and arrange to bring this to the notice of all concerned.
